CITY OF MAYPEARL ORDINANCE NO. <u>2021 02</u>08-1

AN ORDINANCE OF THE CITY OF MAYPEARL, TEXAS, ADOPTING BUDGET AMENDMENTS TO THE ORIGINAL OPERATING BUDGET FOR THE 2020-2021 FISCAL YEAR; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Maypearl, Texas, is a Type A general-law municipality located in Ellis County, created in accordance with the provisions of Chapter 6 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, by Ordinance No. 200928 the City Council of the City of Maypearl, Texas, adopted its budget for Fiscal Year 2020-2021; and

WHEREAS, the City Council has determined that revenues and reserves are available for supplemental appropriation or transfer of certain funds interdepartmentally is economically feasible and in the best interest of prudent budgeting; and

WHEREAS, Section 102.010 of the Texas Local Government Code allows the City Council to make changes to the budget for municipal purposes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAYPEARL:

SECTION 1.

That the fiscal year budget for 2020-2021 for the City of Maypearl, Texas is hereby amended as reflected in the attached Exhibit "A".

SECTION 2.

A true and correct copy of this ordinance showing the approved budget amendments shall be filed with the City Secretary and in the office of the County Clerk as required by Section 102.009 of the Local Government Code. In addition, the City Secretary is hereby directed to ensure that a true and correct copy of the approved budget amendments is posted on the City's website.

SECTION 3.

In the event any clause, phrase, provision, sentence, or part of this ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this ordinance as a whole or any part of provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Maypearl, Texas, declares that it would

have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

SECTION 4.

This Ordinance shall be in full force and effect from and after its passage, and it is so ordained.
